Corruption cannot coexist with the sustainable future we are trying to build for subsequent generations.



Eliminating corruption is a crucial step towards leveraging the amount of public and private investment needed for achieving each of the United Nations Sustainable Development Goals (SDGs). To give the fight against corruption the prominence it deserves, this Manifesto calls for treating zero-corruption as if it were an 18th SDG. It outlines 10 actions to assert our commitment to zero corruption into outcomes.

Harness technology as a gamechanger in the fight against corruption, seizing the opportunities of digital compliance solutions and using a building-block approach
